



Thumbprint Signature Program

Check fraud costs banks and their customers millions of dollars each year. To combat check fraud among Missouri financial institutions, MBA sponsors the Thumbprint Signature Program. This program provides a simple, effective and inexpensive method for preventing and deterring check fraud.



How does it work?

Banks participating in the program ask noncustomers requesting to cash “on-us” checks to apply a thumbprint (using an inkless pad that leaves no mess) to the face of the check, in addition to examining the standard forms of identification. The thumbprint serves as positive ID for use by law enforcement if the check is fraudulent. However, the primary purpose of this program is to serve as a deterrent.

Thumbprint Signature Program Products

All items feature the Thumbprint Signature Program logo printed in two colors on a white background.

- Touch Pads — The pads are round, 2" in diameter, and have an adhesive strip on the back. The pads have a shelf life of 18 months or a minimum of 500 impressions. The logo appears on the top of the pad.
- Teller Window Displays — Post these 6" x 3" tent-style display signs at your teller windows as an additional reminder that you participate in the program.
- Decals — These 4" round decals of the logo, posted at all bank entrances, identify your bank as a participating member and serve as a deterrent to criminals. You also may want to post decals in your drive-through stations.
- Statement Stuffers — These 3.5" x 7.5" brochures explain the mechanics of the program. Send them as a public service announcement to all your account holders and make sure to have plenty on hand for anyone who might have questions about the program. *sold in increments of 500*
